

Kent Nutrition Group Built On Trust “Rewarding Trust” Monthly Contest Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

The Kent Nutrition Group (“Sponsor”) Built on Trust “Rewarding Trust” Contest (“Contest”) starts at 12:00:01 a.m. (CT) on January 20, 2020 and ends at 11:59:59 p.m. (CT) on December 31, 2020 (“Contest Period”) executed each calendar month in 2020 calendar year serving as a monthly contest period (“Monthly Contest Period”). The January contest will be held from January 20, 2020 through January 31, 2020 with following month’s contest starting on the first day of the month and ending on the last day of the month. This Contest shall be subject to these Official Rules, and by entering, all entrants agree to abide and be bound by these rules and the decisions of the Sponsor.

1) Eligibility: This Contest is open only to legal U.S. residents of the following thirty-one (31) states in the United States located in the Kent Nutrition Group trade area, who are the age of majority or older in their state or district of residence at the time of entry. Employees (and their immediate household or family members) of Sponsor and any of its respective parent and sister companies (Grain Processing Corporation, Kent Pet Group and Kent Precision Foods Group) affiliates, subsidiaries, advertising or marketing agencies, prize providers, promotion and delivery contractors, and anyone working directly on Sponsor programs and members of their immediate families (parents, children, step-children, siblings, step-siblings, spouses) and/or persons living in the same households as such persons, whether related or not, are ineligible to enter this Contest and cannot win a prize. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Contest. A complete submission is required in order to enter the contest. Please provide any requested contact information, along with a valid email address and complete all the required questions including a detailed response as to why you trust Kent or Blue Seal feeds. Entries must be received no later than 11:59:59 p.m. CST/CDT (when in effect) on the last day of the Monthly Contest Period to be eligible for the Contest. Limit one entry per person per Monthly Contest Period. Entries must be submitted in English. In the event of a dispute regarding the identity of an entrant, the authorized account holder of the listed email account will be deemed the person who submitted the entry. Disposable or temporary email addresses cannot be used for entry registration or prize acceptance. The “authorized account holder” is the natural person assigned to an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. 3) Winner Selection and Notification: Potential winners are subject to verification by Sponsor whose decisions are final and binding in all matters related to this Contest. Twelve (12) total monthly winners will be selected to win a prize over the entire Contest Period. One (1) winner will be randomly selected during each Monthly Contest Period from among all eligible entries received prior to the drawing. The drawing will occur no later than the 3rd day of the month following the close of entries. Potential winners will be notified shortly after the drawing.
